- 2. Institution shall abide by the provision of Section 12(1)(C) of RTE Act,2009 and Maharashtra RTE Rules 2013.
- 3. RTE Act 2009 provides for Inclusive Education thus children with special needs (CWSN) called "Divyang" shall be part of every class in the school. However "Divyang" children need special policy progrouncements. The State of Maharashtra is framing and issuing various policies in this respect. Flovernment recently issued Resolution No. Mise 2015/(119-A)/SD-6 Dated 8th January,2016 in this reguard, this Govt. Resolution is abiding. All directives, decisions and policies shall be abided by all school of all boards including international boards.

- 12. Indian History especially "History" related to Maharashtra" shall be taught in the school. Failing which this No Objection Certificate shall be withdrawn.
